Other Surfaces On wooden surfaces; The knots are cleaned, any old paint is scraped off, sanded, and then primed

with PRIMERA SYNTHETIC PRIMER.

Surfaces that need repair; It is puttyed with SUPER PASTE and primed with PRIMERA SYNTHETIC PRIMER. (It should not be applied directly on the surface primed with POLİZOLAN, the surface

should be primed with PRIMERA SYNTHETIC PRIMER first.)
